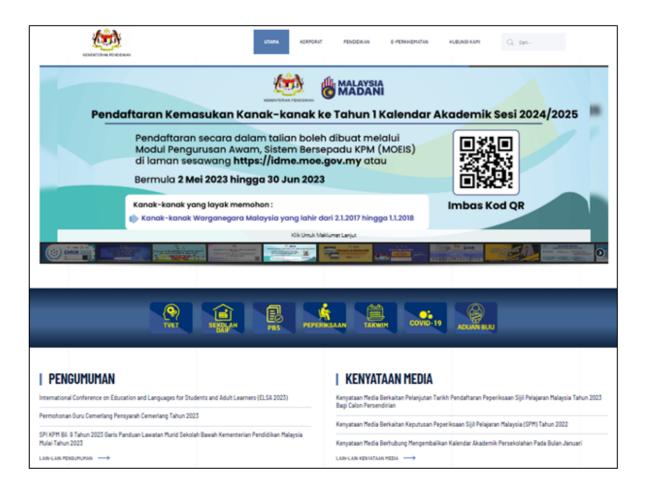
# **Evaluating the Contents of the Official Portal of the Malaysian Ministry of Education: A Website Review**
